SUBJECT: Delegation of Authority to Approve the Expenditure of Appropriated Funds for Trophies and Similar Devices

1. Reference AR 600-8-22 (Military Awards), 11 December 2006, Rapid Action Revision issued 24 June 2013.
2. In accordance with AR 600-8-22, para 1-7e and chapter 11, I delegate authority to approve trophies and similar devices to be awarded within their command or agency for United States military personnel assigned or attached for duty to the following commanders:
 - a. Commander, U.S. Army Combined Arms Center
 - b. Commander, U.S. Army Combined Arms Support Command
 - c. Commander, U.S. Army Cadet Command
 - d. Commander, U.S. Army Recruiting Command
 - e. Commander, U.S. Fires Center of Excellence
 - f. Commander, U.S. Army Maneuver Center of Excellence
 - g. Commander, U.S. Army Maneuver Support Center of Excellence
 - h. Commander, U.S. Army Mission Command Center of Excellence
 - i. Commander, U.S. Army Aviation Center of Excellence
 - j. Commander, U.S. Army Intelligence Center of Excellence
 - k. Commander, U.S. Army Cyber Center of Excellence
 - l. Commander, U.S. Army Training Center
3. Trophies include, but not limited to, loving cups, plaques, badges, buttons, and similar objects that represent the type of achievement or contest. Cash prizes or savings bonds are not authorized. Authorities who approve the purchase of the award will set the monetary limits. However, such awards will not exceed the value of \$75 for an individual award or \$250 for a team award. Cash prizes awarded under the provisions of AR 672-20 are excluded from the provisions of this regulation. This exception does not apply to the purchasing of military coins. Exceptions to this policy remain at this headquarters.

4. CG, TRADOC is the approving authority for units without a commander. All previous delegations related to the expenditure of appropriated funds for trophies and similar devices are revoked.
